RESOLUTION NO. 95-168

RESOLUTION ORDERING THE ANNEXATION OF CERTAIN
PROPERTY IN GRAYS HARBOR COUNTY BY
MASON COUNTY FIRE PROTECTION DISTRICT NO. 12

WHEREAS, the Board of Commissioners for Mason County Fire Protection District No. 12 received and approved a petition for annexation of an area located in Grays Harbor County with boundaries described as follows:

COMMENCING on the SE corner of Section 25, Township 19 North, Range 7 West. Hence West to the SW corner of Section 27, Township 19 North, Range 7 West. Thence North to the SW corner of Section 10, Township 19 North, Range 7 West. Thence West to the SW corner of Section 9, Township 19 North, Range 7 West. Thence North to the NW corner of Section 33, Township 20 North, Range 7 West, thence East to the NE corner of Section 33, Township 20 North, Range 7 West. Thence North to the NW corner of Section 3, Township 20 North, Range 7 West. Thence East to the SW corner of Section 36, Township 21 North, Range 7 West, thence North to the NW corner of Section 36, Township 21 North, Range 7 West. Thence East to the NE corner of Section 36, Township 21 North, Range 7 West. Thence South to the SE corner of Section 36, Township 21 North, Range 7 West. Thence East to the NE corner of Section 1, Township 20 North, Range 7 West. Thence south following the Mason County-Grays Harbor County line to the SE corner of Section 25, Township 19 North, Range 7 West at the point of beginning, and;

WHEREAS, the Grays Harbor County Auditor having reviewed the petition after its approval by the Mason County Fire Protection District Board of Commissioners and certifying that the petition was sufficient pursuant to RCW 52.04.011, having been signed by 58.9 percent of the registered voters residing within the area proposed to be annexed, and;


WHEREAS, the Grays Harbor County Board of Commissioners after having held a public hearing approved the proposed annexation of the above described area of Grays Harbor County into Mason County Fire Protection District No. 12, and;

WHEREAS, the Grays Harbor County Auditor, pursuant to RCW 52.04.011, submitted the proposed annexation to the voters residing within the area described above on November 7, 1995 and certified on November 22, 1995 that the proposed annexation was approved by 88 percent of the registered electors voting at that election; Now, therefore,




